

COVID-19 Preparedness & Response:

Mobility Update Week 6 (27 April - 3 May 2020)

Background and Methodology

DTM relies on its network of key informants and on secondary sources to provide a weekly assessment of mobility and COVID-19 preparedness at priority locations in South Sudan. The updates are released in the beginning of each week based on information collected Monday–Sunday of the previous week. Table 2 on page 2 represents only points recommended by the Points of Entry Technical Working Group (PoE TWG). A more exhaustive list of entry points can be found here.

Overview

As of 3 May 2020, the number of confirmed cases in South Sudan saw a **drastic increase to 49 from six cases** in the <u>previous week</u>. The highest increase took place on 28 April 2020 with 28 new cases resulting from a release of 139 test results of persons who had been in contact with the <u>fifth</u> case. The incident led to an announcement of more stringent measures including an earlier curfew, closure of tea stalls, forced quarantine and punitive measures for those who breach COVID-19 related restrictions. On 29 April 10 pastors were briefly <u>detained</u> for breaching the ban on large gatherings.

Government security forces imposed a further **lockdown at Malakal PoC site** on 27 April 2020 immobilising residents and service providers for two days. As of 30 April, movements picked up again albeit at a reduced rate as before the lockdown since restrictions imposed on 6 April 2020. It should be noted that WHO tested 20 samples from the PoC site, which were negative.


Risk communication **efforts are increasing on a sub-national level** where partners are conducting sensitization and awareness campaigns as well as trainings for medical staff. Partners are also doubling food distributions in many locations to reduce the frequency of congregations. COVID-19 related supplies including viral transport media and PPE have been prepositioned in 20 locations across South Sudan to enable testing in Juba for these areas.

DTM gathered data on **seven displacement sites and 47 transport points** including airports, border crossing points and internal transportation hubs. Temperature screening¹ was conducted at 7 assessed transport points (15%) while additional hand-washing stations were installed at 17 (36%). At a quarter of assessed points movement of persons continued without disruptions (26%) and at a third, most movement has diverted to nearby alternative routes (34%). The movement of cargo continued uninterrupted at three-quarters of assessed points (74%). Key insights on countries bordering South Sudan

- SUDAN: Population movements continue through Timsah / Ere (Raja). DTM confirmed the arrival of South Sudan nationals returning from camps in Darfur to Raja before seasonal rainfall renders these roads impassable. Arrivals from Sudan were also observed in Delieba (Raja), a major transportation hub for persons arriving through eastern routes. Travel and congregation restrictions are not enforced at these points of entry although risk communication efforts are underway. A steep increase in cases prompted the Government of Sudan to impose a nationwide lockdown.
- ETHIOPIA: Cross-border movement to and from Ethiopia at most entry points remain on halt with an exception to cargo. Travel via alternative local roads is still ongoing.
- UGANDA: Truck drivers were on strike at Elegu / Nimule border crossing point as of 30 April 2020 to protest long waiting times and fees demanded by South Sudanese officials to conduct mandatory COVID-19 testing.
- DEMOCRATIC REPUBLIC OF CONGO: Only cargo is allowed to cross the border. Temperature screening at Bazi point of entry came to a halt due to the downscaling of Ebola prepardness activities.
- CENTRAL AFRICAN REPUBLIC: The border point at Source Yubu remains closed for entry
 of persons except cargo. However, COVID-19 related preventive measures are not being taken
 into consideration.
- KENYA: Movement through Nadapal point of entry is limited to cargo with a little small-scale movements through alternative routes.

High Level Task Force

The Government of South Sudan establishes the High Level Task Force on Vice President Dr. Riak Machar.

Closure of edu. facilities

South Sudan Vice President for Service Cluster Hussein Abdelbagi Akol has decided COVID-19 led by The First to close all the schools, teachers training institutes and the universities across the country.

Uganda suspends refugee policy

Uganda's open-door policy for refugees and asylum seekers is suspended for 30 days. Refugees who are already in the country will continue to receive support.

The South Sudan Government confirmed its first ase of COVID-19




Long distance learning

Education ministry to <u>launch</u> distance learning for students. Lessons for core subjects for primary and secondary school students will be delivered over radio stations and national television.

Release of 143 prisoners

Authorities in South Sudan has released 143 prisoners in an effort to combat the spread of the new coronavirus disease in crowded jails.



Preparedness & Response Plan

Ministry COVID-19 releases Country Preparedness and Response Plan (April - September 2020)

South Sudan closes borders

South Sudan closes all airports and seals land borders for passengers. Curfew across country from 8.00PM to 6.00AM. Public institutions working half-time. First suspected case of COVID-19 tested negative.

Quarantine Escape

Over 500 South Sudan nationals described as returnees <u>escape</u> quarantine in Renk, set up at a secondary school after arriving from Sudan.

Closing of Wau Collective Centres

The Diocesan Major Response Team on COVID-19 decides to close several Wau collective centres. As of 12 April 2020, Nazareth, Cathedral, St. Joseph and Lokoloko (3,743 ind. in March 2020 according to DTM population count) are

empty apart from a few stranded households.

Suspension of inter-state travel

The Government has suspended passenger flights as well as public and private iner-state transport for up to two weeks effective from midnight Wednesday 15 April 2020 (Communication from the presidency 25, HLTF 13 April 2020).

Increased testing in Juba

The HLTF directs the Ministry of Health to divide Juba into five zones and to collect over 100 samples per week per zone to enable a minimum



testing capacity of 500 samples a week (Communication from the presidency 28, HLTF 16 April 2020).



Truck Drivers strike Elegu/Nimule border crossing point due to long waiting times upon entry to South Sudan as SSD officials requesting money for testing on entry and when leaving the country.

Arrest at Nimule border

A suspected truck driver who was tested at Kenyan-Ugandan border and tested positive is return package, although not all arrested in Nimiule border have left. IOM DTM confirms crossing point when returning from Juba to Uganda.

IDPs leave Wau PoC AA

265 households (992 IDPs) registered and picked up a an increase in intended permanent exits from Wau PoC AA peaking between 7 and 12 April.

Malakal PoC lockdown

Security forces put the UNMISS base and Malakal PoC site under lockdown due to COVID-19 in Malakal County. SPLA in Malakal alleged that the decision was taken because some people had travelled from Khartoum in Sudan and entered the PoC site. They fear that people may have COVID-19 and spread it to nearby communities.
